I understand that, pursuant to N.J.A.C. 15:18-1.1, a person convicted of a violation of subsection a, b, c, or d of N.J.S. 2C:17-1, concerning arson and related offenses, or N.J.S. 2C:33-3, concerning false public alarms, is ineligible for membership in a volunteer fire company.
